JOB PURPOSE: The Agroforestry Extension Officers will work under the overall guidance of the Ministry of Natural Resources and Commerce and under the direct supervision of the Chief of Forestry. The Agroforestry Extension Officers will also help the Forestry division to implement the objectives and activities under the RMI Forest Action Plan.

KEY RESPONSIBILITIES:

1. Promote tree planting in coastal areas as a response to the impacts of climate change.
2. Assist in training of locals in management of nurseries.
3. Oversee the running and operation of the community nursery;
4. Monitor crops and other plants for pests and diseases; and apply necessary treatment;
5. Liaise and reporting to the Chief of Forestry;
6. Participate in training provided by and through the Ministry of Natural Resources & Commerce;
7. Liaise with local mayor, community and traditional leaders to ensure smooth running and implementation of the Forest Action Plan.
8. Maintain the equipment, tools and supplies provided by and through the Ministry of Natural Resources & Commerce;
9. Participation in other activities as required by the Chief of Forestry; and
10. Perform other related duties as assigned by the Chief of Forestry.

MAIN DUTIES AND OUTCOMES:

1. Provide technical assistance to the responsible organizations, villages, and individuals
2. Ensure that trees planted are well maintained and receive proper security.
3. Sustain the operation of the community nursery;

4. Ensure that the Chief of Forestry is fully aware of the agriculture extension program and activities;
5. Extension Officer's capacity enhanced and to be shared with communities; and
6. Ensure sufficient supply of equipment, tools and other supplies for the community.
7. Promote awareness in the communities and schools on forest management
8. Carry out other duties as required by the Chief of Forestry

DESIRABLE REQUIREMENTS:

Graduation from an accredited high school and/or AA degree, and with at least two (2) years' experience in the field of forestry and agriculture or other related field work.




