**JOB PURPOSE:** Responsible and report to the Attorney General for assisting with the enforcement functions of the division of the Human Trafficking.

**KEY RESPONSIBILITIES:**

1. Develop and maintain effective business relationship with all relevant authorities and clients for procedural compliance.
2. Supervise overall day to day operation of the Health Trafficking officer.
3. Informing all concerned and general public concerning the laws and policies of the Nitijela and the Cabinet, pertaining to the regulations.
4. Reports to the Attorney General regarding the overall operation of the Division
5. Coordinates with other ministries on policies and laws and international practices.

**MAIN DUTIES AND OUTCOMES:**

- 1.1 Act as liaison for the Attorney-General on drug trafficking, involving drug trafficking, people smuggling and money laundering;
- 1.2 Coordinate activities, including regular communication, involving drug trafficking, people smuggling and money laundering with relevant enforcement authorities;
- 1.3 Be a member of the Trafficking in person Taskforce;
- 1.4 Be a member of the National Anti- Money Laundering and Combating the Financing of Terrorism Council;
- 1.5 Prepare and maintain, monthly reports on the above-mentioned trans-boundary issues for the Attorney General's information.
- 1.6 Other tasks as per the instruction of the Attorney General.

**DESIRABLE REQUIREMENTS:**

- Graduate from a recognized college with a Bachelor degree in Criminal Justice with three to Five (3-5) years in specializing in the Human Trafficking Law Enforcement, plus at least four (4) years of work experience in the field. 




